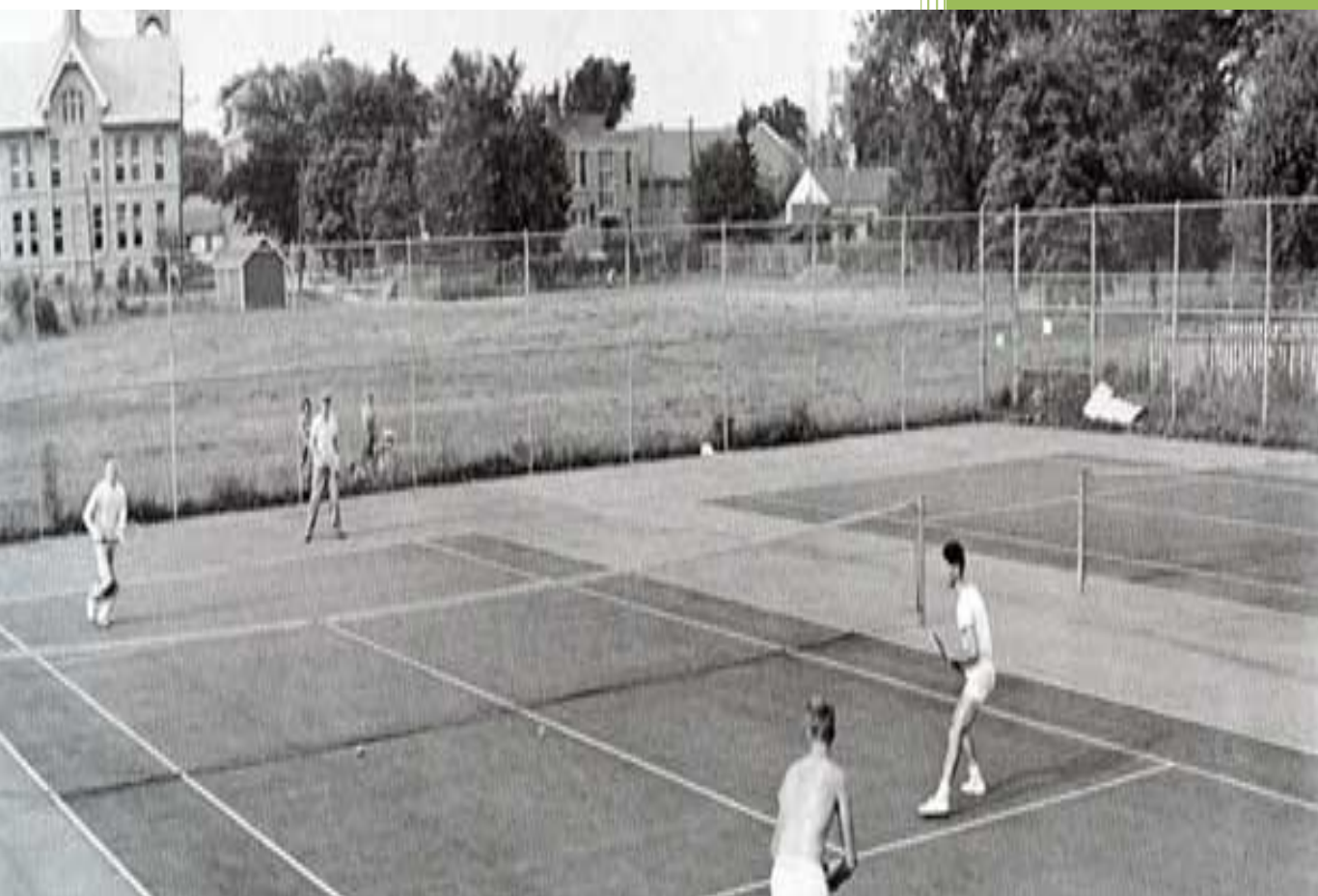

**STATUTE OF THE SLOVENE TENNIS

On the basis of the Societies Act — ZDru-1-UPB2 (Official consolidated version, Official Gazette of the Republic of Slovenia [Uradni list RS], No. 64/11 of 12 August 2011) the Assembly of the Slovene Tennis Association adopted the amended

STATUTE

OF THE SLOVENE TENNIS ASSOCIATION

I. GENERAL PROVISIONS

Article 1

Slovene Tennis Association (hereafter the STA) is a non-profit, independent, voluntary association of tennis clubs and other associations, which was founded due to common interests in the field of recreational and competitive tennis, in accordance with the Olympic principles, in the territory of the Republic of Slovenia. The terms used in the Statute of the STA (hereinafter the Statute) referring to certain persons, written in the masculine gender, are used neutrally for women and men. Any expression in the singular can, where necessary, also be used in the dual or plural, and vice versa.

Article 2 (legal status)

The STA is a legal entity under private law. The registered office of the STA is in Ljubljana. The Board of Directors of the STA (hereinafter the Board of Directors) determines the address of the registered office of the STA by resolution and in accordance with this Statute.

The operation of the STA is not time-limited.

Article 3 (logo, stamp, and flag)

The official logo of the STA is three stylized tennis balls in yellow-green color. Below them is an inscription in blue: TENIS SLOVENIA. The colors are based on and strive for the unification of the national Slovenian sports colors according to the proposal of the Olympic Committee of Slovenia.

The STA stamp is rectangular and consists of the logo with the three tennis balls and the inscription TENIS SLOVENIJA below them.

The flag is white and contains three stylized balls in yellow-green color. Below them is the blue inscription TENIS SLOVENIJA. The ratio of the length and width of the flag is 2:1. The inscription TENIS SLOVENIJA is in blue color and typeface, which also applies to all other signs and documents of the STA.

Changes to the logo, stamp and flag can be adopted by the STA Assembly (hereinafter the Assembly).

Article 4
(establishment and membership in international organizations)

The STA was established March 2, 1940 with the registered office in Maribor, and later in the independent Republic of Slovenia on October 29, 1990, with the registered office in Ljubljana.
STA operates in accordance with the Sports Act and the Societies Act of the Republic of Slovenia.

The STA is a member of the Olympic Committee of Slovenia, Association of Sports Federations (hereafter OCS – ASF) and International Tennis Federation (hereafter ITF).

The STA accepts the decisions of WADA and SLOADA and harmonizes its regulations in accordance with them.

The STA cooperates with sports and other organizations.

The STA, its bodies, commissions and officials respect all acts and decisions of the organizations listed in the second paragraph of this article.

Article 5

The STA represents the interests of athletes-tennis players of the Republic of Slovenia, who are connected to and involved in tennis activities.

The STA is the only representative of the tennis industry in the Republic of Slovenia, which has the right to be included in OCS – ASF, ITF, and other national and international organizations.

The operation of the STA and its bodies is based on the principle of publicity and informs members and the public about its operation.

The STA informs members by means of official notices, with the right of members and authorities to inspect records, via social networks, mail, and electronic media (website, e-mail).

The STA informs the general public through press conferences, electronic media, by means of mass media, publications, social networks and other means.

The President of the STA (hereinafter the President) is responsible for the openness of the work.

II. PURPOSE, GOALS AND TASKS OF THE STA

Article 6

The members of the STA, who are part of the STA, are united in order to jointly develop and direct the development of tennis in an organized manner, by ensuring:

- representation, presentation and dissemination of tennis in the RS,
- promotion of sports and tennis education among young people and support in their establishment at home and abroad,
- sports and recreational activity,
- competitive and top tennis sport (selective),
- determining the system of national competitions, prescribing the conditions for participating and taking care of the organization and management,
- professional, development and other tasks, which are combined within the STA (administrative activity, internal publishing activity, computer data processing, coaching and refereeing activity and other professional workers),
- sports/tennis infrastructure, sports props and equipment,
- activities of national teams and other international activities,

- cooperation with ITF, Tennis Europe (hereafter TE), Association of Tennis Professionals (hereafter ATP), Women's Tennis Association (hereafter WTA) and tennis organizations of other countries,
- respect and protection of the Statute, regulations, instructions and decisions of the ITF, TE, ATP, WTA and STA,
- the code of ethics, the rules of the game and the international calendar of competitions, and ensuring that they are also respected by its members and
- promoting the concept of fair play.

The STA, with its administrative and professional services-commissions, will perform those tasks agreed upon by the members of the STA.

III. STA MEMBERSHIP

Article 7 (STA membership)

Tennis clubs join the STA voluntarily.

Tennis clubs join the STA by submitting a regular statement of the association from the Companies Registry (Agency of the Republic of Slovenia for Public Legal Records and Services), which must not be older than three months, by signing the declaration of accession, by accepting the Statute, Rules of Procedure, Rules and other acts of the STA and by paying the annual membership fee of the STA. Admission to membership is decided by the responsible person - the Director of the STA, based on the submitted documentation. An individual club becomes a member of the STA on the day it is entered in the membership register.

The STA decides on the admission of a member by examining whether the candidate meets the conditions for membership in accordance with the law and the Statute within eight days of receiving the statement, and informs them of this by e-mail.

Article 8 (termination of membership)

Membership of a tennis organization in the STA is terminated:

- if a member arbitrarily withdraws from the STA. In this case, by October 1 of the current year, they must submit a statement of withdrawal to the STA office in writing to the email address info@tenis-slovenija.si or by registered mail to the official STA address, which is published on the STA website www.tennis-slovenija.si. The withdrawal statement must contain the identification data of the member withdrawing from the STA membership. It is not necessary to state the reason for withdrawal.
- if the STA member ceases to exist,
- based on the decision of the Board of Directors and
- if, despite a written warning, they do not pay the prescribed annual membership fee within an additional 15-day period.

Article 9 (suspension of membership rights)

The Board of Directors is responsible for decisions on the suspension of membership rights.

In the case of serious and repeated violations of duties, the Board of Directors may suspend a STA member's rights with immediate effect.

As a rule, the suspension of membership rights lasts one year, unless the Board of Directors withdraws its decision sooner.

In the event that the reasons for the suspension exist even after one year has passed, the Board of Directors can confirm the continuation of the suspension of membership rights with the necessary majority at the next session.

During the suspension of membership rights, the member cannot exercise their rights.

Article 10 (members' rights)

STA members have the right:

- to be informed in a timely manner about the convening of the Assembly and are aware of its agenda,
- to propose items on the agenda of the Assembly and discuss issues of common interest
- to give opinions before making decisions which the Assembly and the Board of Directors are empowered for,
- to participate in the work of the bodies of the association through their representatives (they vote and are elected to the bodies of the STA),
- to ask questions about the responsibilities of the members of STA bodies,
- to be informed about the work of STA bodies, STA organizations, federations, beach tennis
- to inform the STA about their problems and needs and receive expert and organizational support,
- to participate in competitions organized by the STA, as well as provide the same opportunity to their members and
- to exercise their rights on the basis of the Statute and other acts of the STA.

Article 11 (duties of the members)

STA members have the following duties:

- to respect and act in accordance with the Slovenian Olympic Charter, this Statute and other acts of the STA and other decisions of bodies, organizations, federations and beach tennis,
- that they carry out the agreed tasks and contribute to the realization of the objectives of the STA,
- to ensure the protection of the interests and development of the sport of tennis within the framework of the STA,
- that they are responsible for their own development of the sport of tennis,
- to consider the equality and sovereignty of all STA founders, taking into account equal protection of rights, good faith fulfillment of obligations and peaceful resolution of disputes,
- that disputes are resolved by common consent,
- to ensure with the internal statutory provisions that disputes involving themselves or its members and which require resolution before the Disciplinary Judge of the STA (hereinafter the Disciplinary Judge) and refer to sports competition relationships, are resolved only within the framework of the STA, the ITF, and not before regular courts, except in cases where the Slovenian legal order stipulates otherwise,
- that they regularly pay the STA membership fee,

- to notify the STA within 15 days of any change in information (club name, registered office address, e-mail address, statutory reorganization of the association, change of legal representative),
- to maintain an up-to-date register of their members and
- that they do not have sports relations with unrecognized entities and members with suspended membership rights or excluded by the STA.

Article 12

(respect of rules, conflict resolution and powers of the Disciplinary Judge)

The STA, members of the STA and their members are obliged to resolve conflicts arising from sports competition relationships and all other relationships regulated by STA acts, exclusively within the framework of the STA or its bodies, and to respect their decisions.

IV. INVOLVEMENT OF ORGANIZATIONS, FEDERATIONS, BEACH TENNIS

Article 13

The STA also includes the STA Coaching Organization, the STA Referee Organization, the STA Veterans Organization, the Sports Federation for the Disabled of Slovenia, and beach tennis.

V. STA BODIES

Article 14

The STA bodies are

- The Assembly
- The Board of Directors
- The Monitoring Committee
- The President, who is also the Chairperson of the Board of Directors
- 2 (two) Vice Presidents,
- The Director
- Disciplinary body (consists of the Disciplinary Judge and the Commission for Requests and Appeals)
- Competition-registration commission and
- The Council of Experts

The term of office for all bodies lasts 4 years. Elections of bodies are generally public. The Assembly can decide that the elections are secret.

The bodies and their members are autonomous and independent from each other.

The members of bodies are elected freely and independently on the basis of valid election rules in the Rules of Procedure of the Assembly.

The Director of STA (hereinafter Director) is appointed in accordance with Article 27 of this Statute.

Members of the bodies must exclude themselves or be excluded from decision-making procedures in cases where their impartiality and independence are not guaranteed due to a conflict of interests. The decision on the exclusion of the members of the body from the decision-making procedures is adopted by the Board of Directors, and in the event that a decision is made on the expulsion of the members of the Board of Directors, the Assembly decides on the expulsion.

VI. THE ASSEMBLY

Article 15

The Assembly is the highest body of the STA. The Assembly consists of all members of the STA. All other bodies of the STA are responsible for their work to the Assembly.

The Assembly meets in regular or extraordinary sessions.

STA members who have the right to vote are represented at the Assembly by a legal representative or a person authorized by the legal representative (delegate).

Each member has one vote.

Article 16

Delegates are responsible for their work in the STA to the members who delegated them. Their rights and duties are:

- implementing the adopted decisions of the STA bodies in the organizations that appointed them,
- proposing to organizations for consideration issues related to the work of the STA and its bodies,
- familiarization with the opinions and positions of its members before the meeting of the Assembly and
- deciding on all matters and proposals that are on the agenda.

Article 17

(the powers of the Assembly)

The regular Assembly is empowered to decide on:

- adoption of the Statute, its changes, and amendments,
- adopting the Rules of Procedure,
- reports of the bodies, organizations, federations, and beach tennis,
- adopting the annual work report for the previous business year and adopting the annual accounts of the STA,
- adopting the work program with a business plan,
- a long-term program for the development of tennis in Slovenia,
- with the exception of the Director, elects, appoints, and dismisses the members of the STA bodies listed in the first paragraph of Article 14 of the Statute, taking into account the program of the Chairperson of the Board of Directors,
- decides on the purchase and sale of real estate,
- makes final decisions on appeals against the decisions of the Commission for Requests and Appeals,
- all issues that are generally important for the development of tennis,
- other issues in accordance with this Statute and other general acts,
- STA status changes and
- termination of the operation of the STA.

The members of the bodies are responsible to the Assembly for the fulfillment of their tasks and functions.

Article 18

(Assembly sessions)

Assembly sessions are held by the Chairperson or a person designated by the Chairperson at the meeting. The Assembly meets at least once a year.

Article 19
(convocation of the regular Assembly)

The Chairperson of the Board of Directors convenes the regular Assembly at least 30 days before the meeting.

At the convocation, a draft agenda is published in accordance with the Rules of Procedure of the Assembly.

The records of the previous Assembly and materials for the Assembly are sent to members no later than 15 days before the day of the meeting.

Article 20
(extraordinary Assembly)

An extraordinary Assembly is held:

- by decision of the Board of Directors,
- at the request of the STA Monitoring Committee (hereinafter The Monitoring Committee),
- at the request of at least one-third of STA members and
- at the initiative of OCS – ASF.

The extraordinary Assembly is convened by the Board of Directors at least one month before the day of the convening, and no later than 15 days from the day when the request for the convening was given.

If the Board of Directors does not convene an extraordinary Assembly within the specified period, it shall be convened by the proposers.

The extraordinary Assembly discusses and decides exclusively on the agenda items and issues for which it was convened.

Delegates for the STA extraordinary Assembly are delegated in accordance with the provisions that applied to the convening of the last regular Assembly.

The session of the extraordinary Assembly is led by the Chairperson or a person empowered to lead the Assembly appointed by the Chairperson.

VII. BOARD OF DIRECTORS

Article 21

The Board of Directors is the executive body of the Assembly. The term of office of the Board of Directors is 4 years. The Board of Directors is responsible for its work to the Assembly.

Article 22
(terms of reference of the Board of Directors)

Terms of reference of the Board of Directors are:

- proposing changes and additions to general acts of the STA adopted by the Assembly,
- reporting to the Assembly on their work,
- implementation of the resolutions of the Assembly,
- management of the tennis program policy, finances, marketing, and development of the tennis during the term of office,

- deciding on changing the address of the registered office
- calling for tenders and preparing contracts,
- deciding on the exclusion of members and suspension of membership rights,
- deciding on the conclusion of employment and other relationships,
- discussing and defining the work of the Director, bodies, organizations, federations, STA beach tennis,
- preparation and approval of the annual work program and financial plan of the STA,
- appointment and dismissal of the Director,
- confirmation of the STA national team selectors at the proposal of the STA President,
- deciding on the amount of competition, referee, coaching, license, appeal, registration and other fees related to membership and competitions under the auspices of the STA,
- adoption of the Rules of Procedure on the work of bodies and other general acts of the STA,
- issuance of approvals for the conclusion of sponsorship contracts and contracts on the assignment of media rights for contract values over €25,000.00,
- determining the amount of daily allowances, fees, bonuses and salaries of selectors, players, coaches and the expert management of the STA national teams within the framework of the annual financial plan of the STA,
- management of the association's assets,
- deciding on the establishment of legal entities whose owner or partner is or will be the STA,
- on the basis of the proposal of the Commission for Awards, the granting of awards and commendations,
- the right to replace elected members at the Assembly – due to termination of work at the STA or failure to act in the interest of the STA, namely:
 - up to one quarter of the members of the Board of Directors (3 in the case of 13 members),
 - up to two members of the Competition -reg. Commission,
 - the Disciplinary Judge
 - up to two members of the Commission for Requests and Appeals,
 - up to three members of the STA Council of Experts (hereinafter the Council of Experts), namely until the next Assembly,
- decides on other matters within the STA, except those for which the Assembly or another body of the STA is empowered according to this Statute and
- decides in cases of force majeure and matters not provided for by this Statute.

Article 23 (Board of Directors composition)

The Board of Directors has 9 - 14 members, consisting of:

- The Chairperson,
- The Vice-Chairperson,
- 6 – 11 members and
- The Chairperson of the Council of Experts

Chairperson of the Monitoring Committee, Competition - reg. Commission, Coaching Organization, Referee Organization or one of the members of the bodies and the representative for international activities (ITF, TE), may be invited to all meetings of the Board of Directors

In the case of an unfulfilled quota for the number of members of the Board of Directors, the Chairperson may appoint other members of the Board of Directors, who must be approved by the majority of members of the Board of Directors.

The Board of Directors may appoint other permanent or temporary commissions, organizations or working groups.

Article 24
(Board of Directors' deliberations)

The Board of Directors makes decisions at meetings which are held as needed, but at least three times a year.

The Board of Directors has a quorum when the majority of its members is present.

The decision of the Board of Directors is adopted if the majority of all its members votes for it.

Article 25
(convocation and meetings of the Board of Directors)

Meetings of the Board of Directors are convened and chaired by the Chairperson of the Board of Directors, and in their absence by the Vice-Chairperson. In the case of two Vice-Chairpersons, the older of them. The work of the body is regulated by the Rules of Procedure.

VIII. THE PRESIDENT OF THE STA

Article 26
(powers of the President and Vice-Presidents)

The President, who is also the Chairperson of the Board of Directors:

- represents the STA,
- is responsible for the execution of the resolutions of the Assembly,
- holds the Assembly or appoints a person to hold the Assembly,
- appoints the Vice-President and members of the Board of Directors,
- convenes and holds meetings of the Board of Directors,
- proposes to the Board of Directors the Director and selectors of the STA national teams (Davis Cup, Billie Jean King Cup, youth national teams)
- proposes to the Assembly the Chairpersons of the STA bodies,
- takes care of the financial operations and marketing of the STA products,
- is responsible for international affairs and
- performs other tasks within the framework of the STA.

The President may transfer part of their powers in writing to the Vice President.

In case of absence of the President, he is replaced by the Vice-President, who is authorized by the President.

If it was not possible to grant the authorization, the Vice-President replaces him, or in the case of two Vice-Presidents, the older of them.

IX. DIRECTOR OF THE STA

Article 27
(Director of the STA)

The STA has a Director, who is appointed by the Board of Directors on the basis of public tender conditions in accordance with the applicable legislation. The Director's contract is valid for four years. After the contract expires, it can be concluded again. The Director performs their work with due diligence. The Director is the operational manager of the organization's operations in all segments, who advises the management in planning the strategy, ensures its flawless implementation, and actively acquires sponsorship funds.

Responsibilities of the Director:

- representation of the STA,
- preparation of documentation for the needs of public tenders,
- preparation of annual financial reports and operation strategy of the STA,
- management of the financial and material operations of the STA,
- preparation of financial projections and cash flows,
- management of the STA office,
- ensuring the fulfillment of the contractual relations of the STA,
- STA marketing management,
- communication with club representatives, presidents of bodies and organizations, members of the Board of Directors, sponsors, journalists, OCS, the Sports Foundation, the Ministry of Sports and international organizations,
- cooperating and ensuring the functioning of the bodies and commissions of the STA,
- in the case of an invitation, attendance at meetings of bodies and organizations of the STA,
- organization of meetings of the Assembly, meetings of the Board of Directors and attendance,
- ensuring of the decisions of the Assembly and the Board of Directors and
- performance of other tasks arising under this Statute and decisions of the STA bodies.

The Director is obliged to act in accordance with the decisions of the Assembly, the Board of Directors and the instructions of the President.

The rights, obligations and responsibilities of the Director are defined more precisely in the contract, concluded in accordance with the applicable legislation, which is approved by the Board of Directors on the proposal of the President, with the necessary majority of votes.

X. MONITORING COMMITTEE

Article 28 (Monitoring Committee of the STA)

The Monitoring Committee consists of three members, the Chairperson is elected by themselves.

The Monitoring Committee monitors the entire operation of the association and the association's bodies, especially financial and material operations, and reports its findings and conclusions to the Assembly and, if necessary, to the Board of Directors.

The term of office of the Monitoring Committee lasts four years. Decisions are validly adopted if at least two members, out of three present vote for the decision. The Monitoring Committee is responsible for its work to the Assembly.

The Chairperson of the Monitoring Committee, or one of the members, is invited to the meetings of the Board of Directors, and at their own discretion, they may also attend the meetings of other Commissions elected at the STA Assembly.

Members of the Supervisory Board cannot simultaneously be members of the Board of Directors of the STA.

XI. DISCIPLINARY BODY

Article 29 (Disciplinary body)

The Disciplinary body consists of the Disciplinary Judge at the first level and Commission for Requests and Appeals at the second level.

Article 30 (Disciplinary Judge)

The Disciplinary Judge is elected by the Assembly, to which they are also responsible for their work. The disciplinary judge is empowered at first instance to decide on the objection filed by a representative against the decision of the STA bodies. The representative lodges an objection within 8 days of service, addressed to the Disciplinary Judge in writing in two copies, sent by registered mail.

Article 31 (Commission for Requests and Appeals)

The Commission for Requests and Appeals consists of the Chairperson and two members, with the Chairperson being elected by themselves. They meet as needed, especially in case of customer complaints. The members of the commission are elected at the Assembly, to which they are also responsible for their work.

The Commission for Requests and Appeals is empowered to decide on an appeal against the decision of the Disciplinary Judge, filed by a representative within 15 days of its service.

The decision of the Commission for Requests and Appeals can be contested within 30 days of its service. The Assembly decides on the appeal at a regular or extraordinary session. Their decision is final.

XII. COMPETITION-REGISTRATION COMMISSION

Article 32 (Competition-reg. Commission)

The Competition-reg. Commission is an independent professional and consultative body of the STA. In its work, it cooperates with the President, the Board of Directors, the Director, the Council of Experts, the Coaching Organization and other bodies of the STA.

Article 33 (Competition-reg. Commission composition and responsibilities)

The Competition-reg. Commission consists of 5-8 members. The Commission consists of: The Chairperson, Vice-Chairperson, and 3-6 representatives of clubs.

The Chairperson and members of the Competition-reg. Commission are elected by the Assembly.

The Competition-reg. Commission is responsible for the correct and consistent functioning of the competitive system of national and international tournaments in the Republic of Slovenia. In addition, it is responsible for registrations, IT related to the competition program and the competition and registration

rules of the STA (Registration Rules, Competition Rules, League Rules, Competition Rankings Rules and others).

Responsibilities of the CRC:

- creation of criteria for granting national and international competitions under the auspices of the STA,
- preparation of a proposal for the STA summer and winter competition calendar and the allocation of competitions to organizers, approved by the Board of Directors,
- written explanation (attachment) of the allocation of competitions to the organizers,
- regular inspection of the competition calendar,
- preparation of league competitions and draw meetings,
- control over the implementation of competitions,
- monitoring and optimization of the competition system,
- control and management of competition rankings,
- supervision of the work of the referee organization,
- creation and updating of competition and registration rules of the STA,
- handling the registration procedure in case of complications,
- handling the procedure for transfers of competitors between clubs in case of complications,
- attending competitions and establishing a personal relationship with competitors, judges, parents, other stakeholders and
- participation in the project of increasing the number of members in the STA and the development of regions.

Operation of the Competition-reg. Commission is regulated in more detail by the Commission's Rules of Procedure.

XIII. COUNCIL OF EXPERTS

Article 34 (Council of Experts)

The Council of Experts is the expert and advisory body of the STA.

In its work, it cooperates with the President, the Board of Directors, the Director, the Competition-reg. Commission, the Coaching Organization, the selectors of the senior national teams, the captain of the youth national teams and other bodies of the STA.

Operation of the Council of Experts is regulated in more detail by the Rules of Procedure of the body.

Article 35 (Council of Experts composition)

The STA Council of Experts consists of 11 members. It consists of the Chairperson, Vice-Chairperson, seven members, and appointed selectors of the women's and men's senior national teams.

The Chairperson, Vice-Chairperson and members are elected by the Assembly.

Article 36 (responsibilities of the Council of Experts)

The responsibility of the Council of Experts is to plan the strategy for the development of tennis in Slovenia, work with national teams and players in all age categories

Responsibilities of the Chairperson of the Council of Experts:

- representing the Council of Experts and
- Council representation in the Board of Directors.

The work and obligations of the Council of Experts are defined in more detail in the Rules of Procedure of the body.

XIV. OTHER CLAUSES

Article 37

(elections of the President and bodies of the STA)

Any STA member can submit a proposal for the President of the STA.

A person whose candidacy is supported by at least six members of the STA is considered a Presidential candidate.

The candidate must submit the STA program in written form.

The Assembly elects the President, the Board of Directors, the Monitoring Committee, the Monitoring Committee of companies owned or co-owned by the STA, the Disciplinary Judge, the Council of Experts, the Competition-reg. Commission, the Commission for Awards and the Commission for Requests and Appeals for the current mandate period.

All the aforementioned bodies and their members are elected by delegates at the Assembly.

Article 38

(STA assets)

STA assets are cash and other assets acquired by the STA by means of:

- membership fee,
- income from STA activities and material rights,
- gifts and bequests,
- contributions from sponsors and donors,
- assignment of media rights,
- assignment of sponsorship rights,
- assignment of advertising rights,
- assignment of license rights,
- gainful activity,
- from dividends of companies in which the STA has its share,
- public funds and
- other sources.

Assets also include immovable and movable property, as well as tangible and intangible property.

Article 39

(financial operations of the STA)

The provision of data on the financial and material operations of the STA is regulated in the Rules on the Financial and Material Operations of the STA.

Article 40

(representation of the STA)

The STA is represented by the President (legal representative) and the Director. The President, with the written consent of the Board of Directors, can determine the extent of powers of representation of the Director.

Article 41
(gainful activities of the STA)

The STA performs gainful activities related to its purpose and goals as a complementary activity to the non-profit activities of STA. They are performed only to the extent necessary for the realization of their purpose and goals. These are the following activities:

P85.510	Sports and recreation education,
R93.190	Other sports activities,
R93.110	Operation of sports facilities,
G47.990	Other retail sale not in stores, stalls or markets,
I56.210	Event catering activities,
I56.300	Beverage serving activities and
J58.190	Other publishing activities.

Article 42

The STA has its own transaction account.

The STA and companies owned or co-owned by the STA may have one or more transaction accounts. Publicity of financial and material operations is guaranteed by the right of STA members to inspect the relevant documentation at any time upon request with prior notice.

Article 43
(competitor, referee, coach, veteran, recreationist and official)

The rules on the status of competitors, veterans, recreational players and officials are governed by the Registration Rules of the STA.

Article 44
(STA national teams)

The tennis national teams of the Republic of Slovenia represent and promote their homeland and Slovenian tennis at home and abroad.

The STA is responsible for the formation and management of national teams.

Relationships connected to national team appearances are governed by contracts between the candidate and the STA.

Article 45
(awards and commendations)

The STA grants awards and commendations to organizations, competitors, and tennis workers for successful and self-sacrificing fulfillment of set tasks, or for the successes achieved in the organization and development of tennis. Awards and commendations are granted by the Board of Directors at the proposal of the Commission for Awards. The awarding ceremony takes place at the STA annual Assembly and the STA Closing Event.

Any member of the STA may submit a proposal for the awarding of a commendation or award in written form with an explanation and in accordance with the Rules on awards and commendations. The Commission evaluates the received proposals and submits the proposal to the Board of Directors for final decision. The work of the Commission is determined by the Rules of Procedure.

XV. DISSOLUTION OF THE STA

Article 46

The STA may cease activities:

- by decision of the Assembly with the majority of members present,
- on the basis of the final judgement and
- by the law.

The STA assets, which remain after liabilities have been covered, passes in accordance with the regulations on the liquidation of legal entities under private law to the municipality in which the association has its registered office.

Budgetary resources are returned to the budget of the Republic of Slovenia or local communities.

Article 47

This Statute enters into force on the day of its adoption by the Assembly.
